2023-2025 Vision Zero Action Plan includes traffic safety cameras with automated enforcement of traffic laws. Launching *September 2025*. 60% support, 27% support, 11% unsure based of 3,500+ responses from a variety of audiences

Requirements and laws:

- Authorizes a 4-year pilot program
- Independent evaluation
- Regulates traffic safety cameras to protect for fairness, equity, and privacy

-MPD is not allowed to implement or substantively coordinate on the pilot

-Any revenue generated must go to implementation costs or traffic safety / traffic calming measures
